## **Non Disclosure Agreement**

This non disclosure agreement is entered into on [Agreement.CreatedDate] between Dior Jordan herein referred to as “the Service Provider” and Client of Dior Jordan Parties herein referred to as “the client”.

The Service Provider acknowledges the Client may receive information regarding the Service Provider’s business, practices, or other information that may be considered confidential. Therefore, the Parties are in agreement to the following terms and conditions of this agreement.

### Confidentiality

### Confidentiality Protection

The Client understands that the information deemed confidential is of value to the Service Provider and shall hold all information at the same level of confidentiality as personal information is held.

The Client agrees to hold all confidential information made available to standard non disclosure terms and will not make said information available or disclose said information to third party vendors or individuals without the Service Provider’s prior written consent.

The client agrees to not disclose the privacy of the Party and that any and everything at the party is to not be spoken about outside of the event along with the protection of the Dior Jordan brand and Dior Jordan himself. The client agrees not to speak ill of the Dior Jordan brand and Dior Jordan himself.

### Unauthorized disclosure

In the event any information is found to be disclosed by the Client without prior written approval from the Service Provider, the Service Provider will be permitted to seek remedies including, but not limited to legal assistance and termination of this agreement.

**Indemnity**

The Client agrees to hold the Service Provider harmless in the instance of any loss, damage, theft, or injury for any reason.

This is inclusive of any attorney fees, court costs, hospital fees, and loss of funds that may occur from such negligence.

**Entirety**

This non disclosure agreement shall serve as the entire agreement between the Parties and shall prevail over any prior agreements conducted in written or oral form by the Parties.

**Term**

The obligations of this non disclosure agreement shall survive indefinitely including through termination or conclusion of this agreement.

**Jurisdiction**

This non disclosure agreement shall fall under the jurisdiction of Miami Florida, furthermore all legal proceedings occurring in relation to this agreement shall be conducted as such.

The prevailing party in such proceedings shall have the opportunity to seek compensation for all court fees associated with said proceedings.
